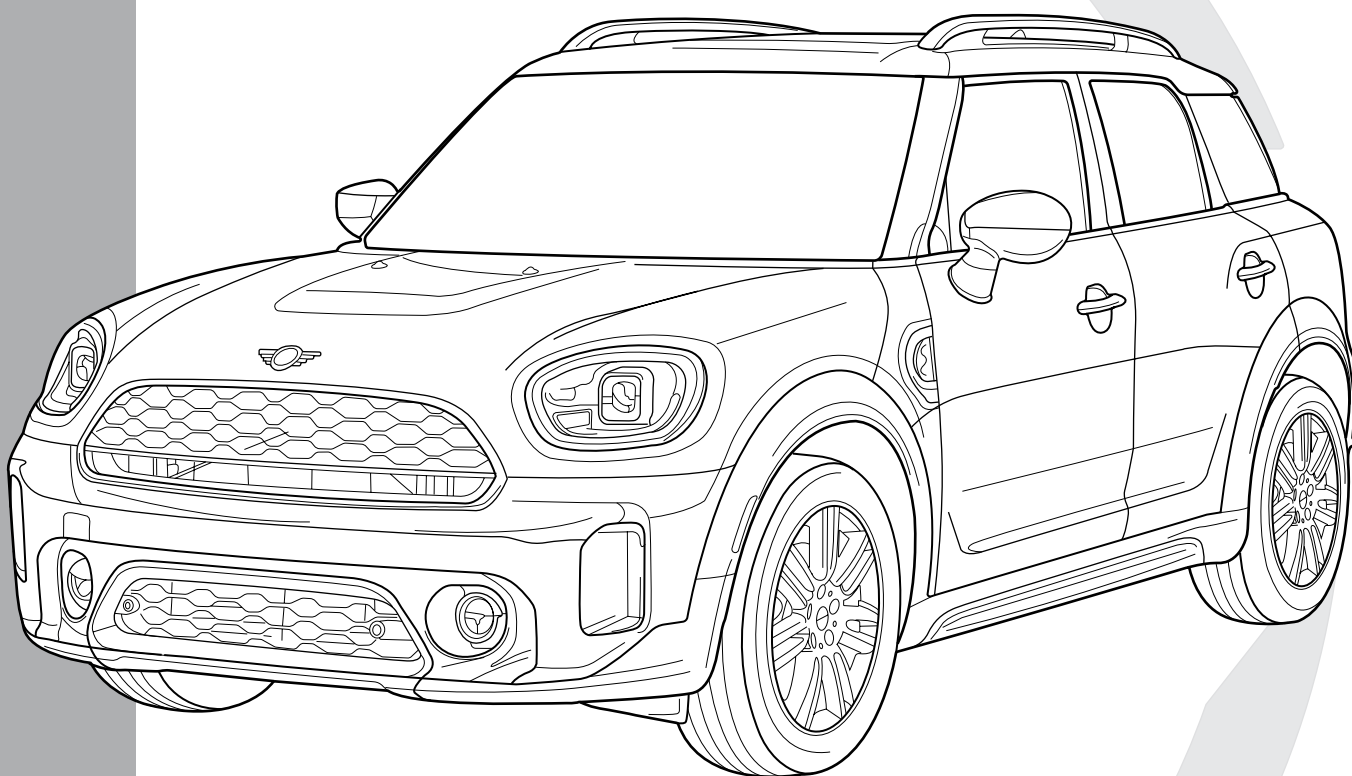

Montage

- Voor de montage moet de trekhaak eerst op het voertuig gepresenteerd worden.

De belasting van een aanhangwagen en van een accessoire dat op de koppelingskogel wordt voorzien, zijn anders van aard. Voor beiden kunnen verschillende limieten van toepassing zijn. Hiervoor verwijzen we naar het instructieboekje van de wagen of naar uw concessiehouder.

Montage

- Présenter l'attelage sous le véhicule avant d'effectuer le montage.

La charge d'une remorque ou d'un accessoire monté sur la boule d'attelage, sont de nature différentes. Des limites différentes peuvent s'appliquer à l'un et à l'autre. Nous vous recommandons de vous référer à votre livret d'instructions ou de vous renseigner chez votre concessionnaire.

Fitting

- Present the towbar under the car first to check if all points are right.

The load of a trailer and of an accessory fitted on the towing ball are of a different nature. Different limits may apply to both. For this matter, we refer to the instruction manual of the vehicle or we advise you to contact your concessionaire.

Montage

- Halten Sie die Anhängerkupplung zunächst unter das Fahrzeug und prüfen Sie, ob alle Punkte übereinstimmen.

Die Last eines Anhängers und die Last eines an der Zugkugel montierten Zubehörs unterscheiden sich grundsätzlich. Für beide können unterschiedliche Grenzwerte gelten. Wir verweisen diesbezüglich auf die Betriebsanleitung des Fahrzeugs oder empfehlen Ihnen, sich an Ihren Vertragshändler zu wenden.

Montaje

- Presentar el enganche debajo del vehículo antes de realizar el montaje.

La carga de un remolque y un accesorio montado en una bola de remolque son de una naturaleza diferente. Se pueden aplicar diferentes límites a ambos. Para este asunto, nos referimos al manual de instrucciones del vehículo o le recomendamos que contacte a su distribuidor.

Montering

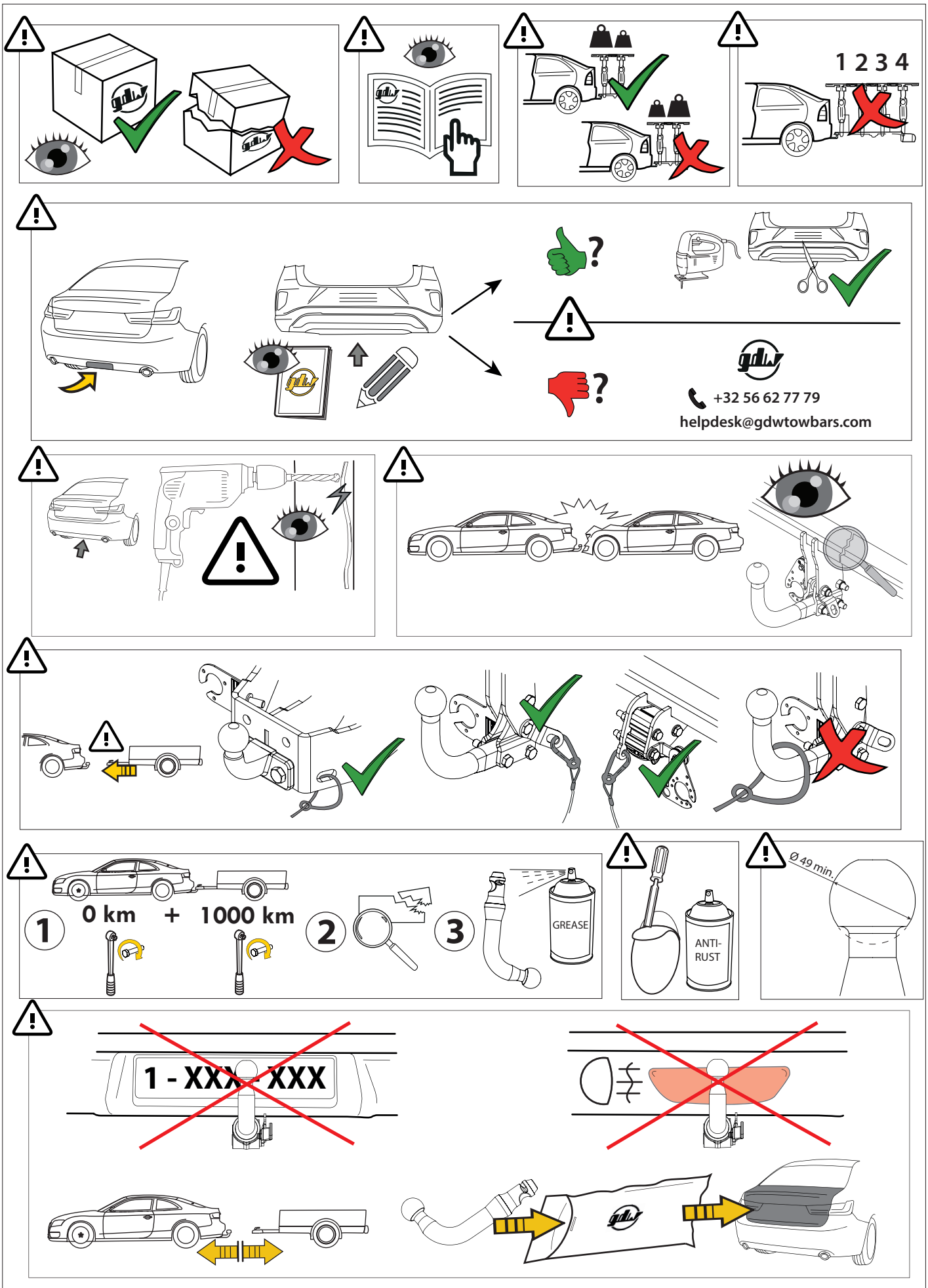
- Præsenter trækstangen under bilen først for at kontrollere, om alle punkter er rigtige.

Per facilitare il controllo della compatibilità del dispositivo di traino sul veicolo, è opportuno confrontare le masse riportate sulla carta di circolazione del veicolo con le masse di riferimento sotto riportate (**T** ed **C**):

To simplify checking the compatibility of the towing device on the vehicle, it is advisable to compare the masses shown on the vehicle registration certificate with the reference masses shown below (T and C):

T = Massa complessiva del veicolo in kg Total vehicle mass in kg
C = Massa rimorchiabile del veicolo in kg Towable mass of the vehicle in kg

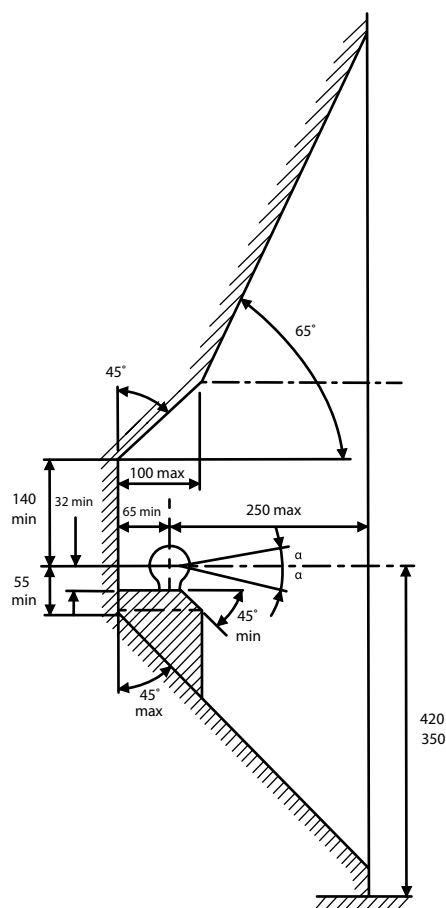

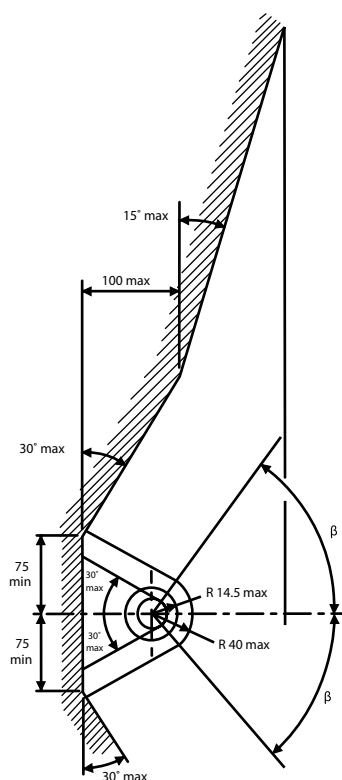
